Notice to Investors for Importing Vehicles Essential for the Authorized Operations (Revision)

Thilawa Special Economic Zone Management Committee hereby revises Notice No.05/2015 dated 7 October 2015 regarding "Importing Vehicles under the Provisions of Myanmar Special Economic Zone Law" as follows;

1. Pursuant to Section 44 (a), (b) and (d) of Myanmar Special Economic Zone Law, Thilawa Special Economic Zone Management Committee hereby permits the Developer, a Business in Free Zone (or Free Zone Business) or a Business in Promotion Zone (or Other Business) to enjoy the exemption of customs duties and other taxes for the import of motor vehicles which are essential for their Authorized Operations as under;

1) Type of motor vehicles:

- Only commercial vehicles such as passenger buses including one-box type passenger van, delivery vans, pick-up trucks and/or other type of trucks are permitted to be imported free from customs duties and other taxes.
- No luxury type passenger or commercial vehicle and/or motorcycle shall be permitted to be imported free from customs duties and other taxes.

2) Number of vehicles:

- Total five (5) vehicles shall be permitted to be imported free from customs duties and other taxes.

3) Conditions:

- No used vehicle shall be permitted to be imported free from customs duties and other taxes.
- The developer or a Businesses shall be permitted to purchase the used vehicles only from domestic market.

- 2. Notwithstanding above stipulations, "Logistics Business" which is provided the status of "Business in a Free Zone (or Free Zone Business)" by the Thilawa Special Economic Zone Management Committee may be permitted to import more than 5 vehicles without payment of customs duties and other taxes in case the Management Committee deems the number of vehicles requested by such Logistics Business is appropriate for carrying out the Authorized Operations. In this case, the Logistics Business shall submit the Master List, stating the specification and use of each vehicle, with its catalogue to the Thilawa Special Economic Zone Management Committee for its approval and registration of import of such vehicles.
- 3. In case the Developer, a Business in Free Zone (or Free Zone Business) or a Business in Promotion Zone (or Other Business) wishes to import more than 5 vehicles, which are compatible with the definition under 1-1) and 1-3) above, the Developer or such Business shall submit the Material List, stating the specification and use of each vehicle, together with its catalogue, to the Thilawa Special Economic Zone Management Committee for its approval and registration of import of such vehicles. Thilawa Special Economic Zone Management Committee may permit such import with the payment of customs duties and other taxes, when it considers such import of vehicle shall be essential for the Authorized Operations of the Developer or a Business.
- 4. Upon issuance of this NOTICE, Notice No.05/2015 dated 7 October 2015 regarding "Importing Vehicles under the Provisions of Myanmar Special Economic Zone Law" shall become null and void.
